

UTAH MAMMOTH MAKEOVER SWEEPSTAKES — OFFICIAL TERMS & CONDITIONS

Effective date: May 15th - May 30th

1. Sponsor

"Utah Mammoth Makeovers" (the "Sweepstakes") is presented/sponsored by RGS Exteriors ("Sponsor"), in partnership with Smith Entertainment Group ("SEG").

2. Eligibility

Open only to legal residents of the State of Utah who are 18 years of age or older at time of entry. Employees, officers, directors, agents, and immediate family members (spouse, parents, siblings, children and their respective spouses) of Sponsor or SEG or their affiliates are not eligible.

3. Entry Period

Entry period: May 15, 2026 – May 30, 2026. Sponsor reserves the right to modify dates; any changes will be posted.

4. How to Enter

Enter by submitting an online entry form at the Sweepstakes entry page during the Entry Period. Each person may submit one (1) entry. You may enter for yourself or nominate another eligible person. By nominating, you confirm you have permission to provide the nominee's information.

5. Winner Selection

Two (2) winners will be selected following a narrowing/selection process conducted by SEG and RGS Exteriors. Selection criteria will include suitability of the candidate's story and community impact as determined by Sponsor in its sole discretion. Selection date to be determined. Decisions are final.

6. Prize

Each winner will receive siding, gutter, or window upgrades/replacements (the "Prize") to be designed and installed by RGS Exteriors. No cash equivalent or substitution is permitted except Sponsor reserves the right to substitute a prize of comparable value if necessary. Approximate retail value (ARV) of each Prize: to be determined. Winners must be available for site inspection and scheduling with Sponsor. Sponsor is not obligated to make structural or other repairs beyond the scope of the Prize as determined by Sponsor.

7. Taxes and Ongoing Costs

Sponsor will not require winners to pay prize award taxes; Sponsor will be responsible for any taxes directly associated with awarding the Prize. However, winners are solely responsible for any ongoing costs arising from the Prize, including increases in property taxes, homeowner insurance premiums, maintenance, or other post-installation costs.

8. Notification and Claiming Prize

Potential winners will be notified by email to the address provided on their entry. Potential winners must respond within twenty-four (24) hours of notification or an alternate winner may be selected. If a potential winner cannot be contacted, fails to respond, or is ineligible, the prize may be forfeited.

9. Publicity Release

By entering, entrants agree that Sponsor and its designees may use entrant's name, city/state, photograph, voice, likeness, biographical information, and/or prize information for advertising, publicity and promotion purposes in any media without additional compensation, unless prohibited by law. Winners must sign any publicity and/or other releases that Sponsor may require.

10. Data Collection and Privacy

By entering the Sweepstakes entrants consent to Sponsor's collection, use and disclosure of their personal information for administration of the Sweepstakes and for marketing purposes by Sponsor (including contacting entrants with offers for RGS Exteriors services). A separate Privacy Policy may apply; contact Sponsor for details.

11. Release and Limitation of Liability

By participating, entrants and winners release and hold harmless Sponsor, SEG, and their respective parent companies, affiliates, subsidiaries, advertising and promotion agencies, suppliers and each of their respective officers, directors, employees and agents (the "Released Parties") from and against any claim or cause of action arising out of participation in the Sweepstakes or receipt, ownership or use of any prize, including without limitation personal injury, death, property damage, loss, or liability. IN NO EVENT WILL SPONSOR'S OR SEG'S AGGREGATE LIABILITY EXCEED THE RETAIL VALUE OF THE PRIZE AWARDED. SOME JURISDICTIONS DO NOT ALLOW THE LIMITATION OR EXCLUSION OF LIABILITY, SO THE ABOVE LIMITATION MAY NOT APPLY TO YOU.

12. Compliance with Laws; Insurance

Prizes must be installed in accordance with all applicable laws, building codes, zoning requirements and homeowner insurance requirements. Winners are responsible for obtaining any required permits and for any consequences to coverage or premiums related to the Prize. Sponsor makes no warranties regarding workmanship or subsequent impacts on insurance or property assessments beyond any standard warranties provided by RGS Exteriors.

13. Disputes; Governing Law

These Official Rules are governed by the laws of the State of Utah, without regard to conflict of laws principles. Any dispute arising out of or related to the Sweepstakes shall be resolved exclusively in the state or federal courts of Salt Lake County, Utah, and entrants hereby consent to personal jurisdiction therein. Entrants waive any right to bring claims as a class or representative action; all claims must be brought in an individual capacity only. Any claim must be filed within one (1) year of the date the cause of action arises or it is forever barred.

14. Odds of Winning

Odds of winning depend on the total number of eligible entries received during the Entry Period. Because winners are selected based on story and community impact criteria rather than by random drawing, not all entrants will have an equal chance of selection.

15. General Conditions / Force Majeure

Sponsor reserves the right to cancel, suspend, or modify the Sweepstakes at any time if fraud, technical failures, or other circumstances beyond Sponsor's reasonable control compromise the integrity of the promotion, as determined by Sponsor in its sole discretion.

16. Prohibited Conduct

Automated, bulk, or third-party entries are prohibited. Any attempt to circumvent these rules, commit fraud, or tamper with the entry process will result in disqualification. Sponsor reserves the right to disqualify any entrant who acts in bad faith or in violation of these Official Rules.
